

Farm Commodity Provisions in the 2014 Farm Bill (P.L. 113-79)

Summary

The farm commodity program provisions in Title I of the Agricultural Act of 2014 (P.L. 113-79, the 2014 farm bill) include three types of support for crop years 2014-2018:

- Price Loss Coverage (PLC) payments, which are triggered when the national average farm price for a covered commodity (e.g., wheat, corn, soybeans, rice, and peanuts) is below its statutorily fixed "reference price";
- Agriculture Risk Coverage (ARC) payments, as an alternative to PLC, which are triggered when crop revenue is below its guaranteed level based on a multi-year moving average of historical crop revenue; and
- Marketing Assistance Loans (MALs), which offer interim financing for the loan commodities (covered crops plus several others) and, if prices fall below loan rates set in statute, additional low-price protection, sometimes paid as loan deficiency payments (LDPs).

The enacted 2014 farm bill eliminated "direct payments," which were provided annually to producers and landowners of covered commodities from 1996 to 2013 based on historical production and a fixed payment rate set in statute. All farm program support now consists of variable payments. The PLC and ARC programs are enhanced relative to their predecessors via higher reference prices for PLC and more "local" coverage for ARC (whereby payments are triggered by county or individual losses rather than at the state level). In a major departure from previous farm bills and in response to a trade dispute with Brazil, upland cotton is no longer a covered commodity, with support for that crop now provided by a new crop insurance policy called the Stacked Income Protection Plan (STAX).

Approximately three-fourths of the 10-year, \$47 billion in savings associated with the elimination of 2008 farm bill commodity programs was used to offset the costs of revising the overall farm safety net, specifically farm programs in Title I of the 2014 farm bill, adding permanent disaster assistance (also in Title I), enhancing the permanently authorized federal crop insurance program (Title XI), and enhancing the Noninsured Crop Disaster Assistance Program or NAP (Title XII). Crop insurance is available for more than 100 crops, including fruits and vegetables, and is designed primarily to cover losses from natural disasters. Farm programs do not require a participation fee, while crop insurance requires participating farmers to pay part of program costs.

The enacted 2014 farm bill sets a \$125,000 per person cap on the total of PLC, ARC, marketing loan gains and loan deficiency payments. The limit applies to the total from all covered commodities except peanuts, which has a separate \$125,000 limit. Also, to be eligible for payments, persons must be "actively engaged" in farming. The 2014 farm bill instructs USDA to write regulations (beginning with the 2015 crop year) that define "significant contribution of active personal management" to more clearly and objectively implement existing law. A single, total adjusted gross income (AGI) limit for payment eligibility is established at \$900,000, which is less than the sum of the two separate limits (farm and non-farm) in the 2008 farm bill.

The Congressional Budget Office cost estimate (score) of the Title I provisions represents five-year savings of \$6.3 billion and 10-year savings of \$14.3 billion (both relative to baseline projections made in May 2013 assuming continuation of the 2008 farm bill). If these scores are added to the 2013 CBO baseline of budget outlays used to write the farm bill, then CBO's estimated cost of Title I is \$23.6 billion for FY2014-2018 and \$44.5 billion over 10 years.

Introduction

On February 7, 2014, President Obama signed into law a new five-year omnibus farm bill, the Agricultural Act of 2014 (H.R. 2642; P.L. 113-79, the 2014 farm bill). The House had voted, 251-166, to approve the conference report (H.Rept. 113-333) on January 29, 2014, and the Senate approved the conference report on February 4, 2014, by a vote of 68-32. The U.S. Department of Agriculture (USDA) is now implementing the provisions, most of which take effect this year.

This report describes the farm commodity programs in Title I of the 2014 farm bill for "covered commodities" such as wheat, corn, soybeans, rice, and peanuts. Producer support is provided for the 2014-2018 crop years primarily through either statutory ("reference") prices or historical revenue guarantees based on the five most recent years of crop prices and yields.¹

Important policy developments in the new law are also discussed and compared to prior law. The most significant policy change for commodity programs in the 2014 farm bill was the elimination of fixed direct payments and the enhancement of variable payments to farmers and landowners when crop prices or revenue declines.

Table A-1 provides detailed descriptions of farm commodity program provisions compared with prior law. Background

Policy Rationale for Farm Subsidies

Federal farm support began in the 1930s through Depression-era efforts to raise farm household income when commodity prices were low because of prolonged weak consumer demand. While initially intended to be a temporary effort, the commodity support programs survived, but have been modified away from supply control and management of commodity stocks (which was designed to prop up prices) into direct income support payments. The 2014 farm bill continues traditional farm support via variable payments relative to statutory price levels or historical crop revenue.

Proponents of farm commodity programs argue that federal involvement in the sector is needed to stabilize and support farm incomes by shifting some of the risks to the federal government. These risks include short-term market price instability and longer-term capacity adjustments. Proponents see the goal of farm policy as maintaining the economic health of the nation's farm sector so that it can use its comparative advantage in feeding the nation and competing in the global market for food and fiber. Critics argue that farm commodity programs waste taxpayer dollars, distort production of certain crops, capitalize benefits to the owners of the resources,

encourage concentration of production, and comparatively harm smaller domestic producers and farmers in lower-income foreign nations.

Authorizing Legislation

The authority for USDA to operate farm commodity programs comes from three permanent laws, as amended: the Agricultural Adjustment Act of 1938 (P.L. 75-430), the Agricultural Act of 1949 (P.L. 81-439), and the Commodity Credit Corporation (CCC) Charter Act of 1948 (P.L. 80-806). Congress typically alters these laws through multi-year omnibus farm bills to address current market conditions, budget constraints, or other concerns.

If a new farm bill is not enacted when an old one expires, farm programs would revert to the permanent laws mentioned above for most of the major program crops. Under permanent law, eligible commodities would be supported at levels much higher than they are now, and many of the currently supported commodities might not be eligible. Since reverting to permanent law is incompatible with current national economic objectives, global trading rules, and federal budgetary policies, pressure builds at the end of one farm bill to enact another.²

The 2014 farm bill (P.L. 113-79) contains the most recent version of the farm commodity support programs. It supersedes the commodity provisions of previous farm bills, and suspends the relevant price support provisions of permanent law.

Eligible Commodities

Federal support exists for about two dozen farm commodities representing about one-third of gross farm sales. During FY2005-FY2014, five crops (corn, cotton, wheat, rice, and soybeans) accounted for about 90% of these payments.³

- Under the 2014 farm bill, the "covered commodities" are the primary crops eligible for farm support: wheat, oats, and barley (including wheat, oats, and barley used for having and grazing); corn, grain sorghum, long grain rice, medium grain rice, and pulse crops (dry peas, lentils, small chickpeas, and large chickpeas); soybeans, other oilseeds (including sunflower seed, rapeseed, canola, safflower, flaxseed, mustard seed, crambe, and sesame seed), and peanuts.
 - In a major departure from all previous farm bills and in response to a trade dispute with Brazil, upland cotton is no longer a covered crop, with support for that crop now provided by a new crop insurance policy called the Stacked Income Protection Plan (STAX).⁴
- "Loan commodities" include all of the "covered commodities" plus upland cotton, extra long staple cotton, wool, mohair, and honey. These commodities are eligible for the marketing loan program only.

- The 2014 farm bill replaces the dairy product price support program and Milk Income Loss Contract (MILC) payments with new dairy programs to (1) protect producer margins (milk prices minus feed costs), and (2) buy excess dairy products to boost demand when margins drop below certain levels.
- Sugar support is indirect through import quotas, price guarantees, and domestic marketing allotments. No direct payments are made to growers and processors. There was no change to the sugar program in the 2014 farm bill. See CRS Report R42551, Sugar Provisions of the 2014 Farm Bill (P.L. 113-79).

Meats, poultry, fruits, vegetables, nuts, hay, and nursery products (about two-thirds of farm sales) do not receive direct support or payments under the commodity programs of the farm bill. However, livestock and tree fruit producers receive disaster support under Title I of the 2014 farm bill. (See **Table A-1** and CRS Report RS21212, *Agricultural Disaster Assistance*, for a description of disaster programs.) Also, under the permanently authorized federal crop insurance program, subsidized crop insurance is available for more than 100 crops, including fruits and vegetables which are not supported by farm programs. Crop insurance is designed primarily to cover losses from natural disasters and within-season price or revenue declines (see CRS Report R40532, *Federal Crop Insurance: Background*).

Definition of "Farm"

The definition of "farm" used to administer the commodity programs is different from other statistical or perceived definitions of farms. Under Farm Service Agency (FSA) regulations, a "farm" for program payment purposes is one or more tracts of land considered to be a separate operation.⁵ Land in a farm does not need to be contiguous; however, all tracts within a farm must have the same operator and the same owner (unless all owners agree to combine multiple tracts into a single FSA farm). Thus, one producer may be operating several "farms" if he/she is renting land from several landlords, or has purchased land in several tracts.

Base Acres

For the purpose of calculating program payments, the term "base acres" is the historical planted acreage on each FSA farm, using a multi-year average from as far back as the 1980s. ⁶ Technically, a farm's base with respect to a covered commodity is the number of acres in effect under the 2008 farm bill (7 U.S.C. 8702, 8751) as of September 30, 2013, subject to any reallocation, adjustment, or reduction under the 2014 farm bill. Base is calculated for each covered commodity and transfers to the new owner when land is sold, making the new landowner eligible for farm programs.

Because a farmer's actual plantings may differ from farm base acres, program payments may not necessarily align with financial losses associated with market prices or crop revenue. In order to better match program payments with farm risk, the 2014 farm bill provides farmers with a one-time opportunity to update individual crop base acres by reallocating acreage within their current

base to match their actual crop mix (plantings) during 2009-2012. Farmers can also choose to not reallocate their base if they expect payments to be maximized under their current base. In the case of cotton, which is no longer a covered commodity, former cotton base acres are renamed "generic base" and added to a producer's base for potential payments if a covered crop is planted on the farm.⁷

"Partially Decoupled" Payments

Payments under the new programs in the 2014 farm bill are made on base acres, not current plantings. This feature—decoupling payments from current plantings—is intended to better comply with World Trade Organization (WTO) rules on domestic support and to minimize any influence on producer behavior and prevent any subsequent market distortion. The payments are considered "partially decoupled" because the payment amount remains connected to current market prices. In the 2008 farm bill, farm payments were calculated using either base or planted area, depending upon the program.

Eligible Producers

The 2014 farm bill defines a producer (for purposes of farm program benefits) as an owner-operator, landlord, tenant, or sharecropper that shares in the risk of producing a crop and is entitled to a share of the crop produced on the farm. For payment eligibility, a term commonly used in federal regulations is "actively engaged in farming," which generally means providing significant contributions of capital (land or equipment) and labor and/or management, and receiving a share of the crop as compensation. The 2014 farm bill requires USDA to write new regulations that define "significant contribution of active personal management." See "Payment Limits," below.

Producers do not pay to participate in farm programs. However, an individual must comply with certain conservation and planting flexibility rules. Conservation rules include protecting wetlands, preventing erosion, and controlling weeds. Planting flexibility rules allow crops other than the program crop to be grown, but under the 2014 farm bill, eligible payment acreage is reduced when fruits, vegetables, or wild rice are planted in excess of 15% of base acres (or 35% depending upon a farmer's program choice discussed below). Also, a producer on a farm may not receive farm program payments if the sum of the base acres on the farm is 10 acres or less.

A farm enterprise usually involves some combination of owned and rented land. Two types of rental arrangements are common: cash rent and share rent. Under cash rental contracts, the tenant pays a fixed cash rent to the landlord. The landlord receives the same rent, bears no risk in production, and thus is not eligible to receive program payments. The tenant bears all of the risk, takes all of the harvest, and receives all of the government subsidy.

Under share rental contracts, the tenant usually supplies most or all of the labor and machinery, while the landlord supplies land and perhaps some machinery or management. Both the landlord and the tenant bear risk in producing a crop and receive a portion of the harvest. Both are eligible to share in the government subsidy.

Even though tenants might receive all of the government payments under cash rent arrangements, they might not keep all of the benefits if landlords demand higher rent. Economists widely agree that a large portion of government farm payments passes through to landlords, since government payments boost the rental value of land. The amount of total land in farms rented by farm operators has ranged between 34% and 43% of farmland during 1964-2007.¹⁰

Eliminated 2008 Farm Bill Programs

Under the enacted 2014 farm bill (P.L. 113-79), farm support for traditional program crops is restructured by eliminating the direct payment (DP) and counter-cyclical payment (CCP) programs, and the Average Crop Revenue Election (ACRE) program. For the 1996 through 2013 crop years, direct payments were made to producers and landowners based on historical production of corn, wheat, soybeans, cotton, rice, peanuts, and other "covered" crops. Direct payments lost political support in recent years because recipients did not need to suffer an income loss in order to receive a payment. Approximately three-fourths of the 10-year, \$47 billion in savings associated with the elimination of current farm programs was used to offset the costs of revising farm programs in Title I of the 2014 farm bill, adding permanent disaster assistance (also in Title I), enhancing the permanently-authorized federal crop insurance program (Title XI), and enhancing the Noninsured Crop Disaster Assistance Program or NAP (Title XII).

Farm Commodity Program Provisions

The farm commodity program provisions in Title I of the 2014 farm bill include three types of support for crop years 2014-2018:

- **Price Loss Coverage (PLC) payments**, which are triggered when the national average farm price for a covered commodity is below its statutorily-fixed "reference price";
- Agriculture Risk Coverage (ARC) payments, as an alternative to PLC, which are triggered when crop revenue is below its guaranteed level based on a multivear moving average of historical crop revenue; and
- Marketing Assistance Loans (MALs) that offer interim financing for the loan commodities (covered crops plus several others as indicated above) and, if prices fall below loan rates set in statute, additional low-price protection, sometimes paid as loan deficiency payments (LDPs).

Farmers with base acres of covered commodities have a one-time irrevocable decision to choose between PLC and "county" ARC (based on a county guarantee) on a commodity-by-commodity basis for each farm. Alternatively, all covered crops on a farm can be enrolled in "individual" ARC, which is based on a farm-level guarantee. (See "Agriculture Risk Coverage (ARC)," below.) If no choice is made, the producer forfeits any payments for the 2014 crop year and the farm is enrolled automatically in PLC for the 2015-2018 crop years. The "optimal" decision depends in part on expected prices through 2018 relative to guarantees in each program.

The PLC and ARC programs are similar conceptually to the 2008 farm bill's counter-cyclical payment (CCP) program and Average Crop Revenue Election (ACRE) program, respectively. However, compared with the previous programs, they have enhanced levels of protection from low prices (i.e., higher price parameters in PLC) or revenue loss (i.e., county- or farm-level guarantees for ARC rather than state-level in ACRE).

PLC and ARC payments are proportional to base acres, and not planted acres. Payments are made with a lag of approximately one year as annual price and yield data are compiled for USDA's calculations. USDA is to issue payments beginning October 1 after the end of each marketing year, which varies by crop. For example, the marketing year for corn harvested in fall of 2014 ends in August 2015.

Marketing assistance loans are available for covered crops and other loan commodities. The program continues mostly unchanged from the 2008 farm bill, with loan rates set at relatively low levels compared to historical prices.

All three types of payments are subject to a combined payment limit of \$125,000 per person. Also, the income limit for program eligibility is \$900,000 for adjusted gross income (three-year average). See "Payment Limits" and "Adjusted Gross Income (AGI) Limit," below.

Price Loss Coverage (PLC)

For each covered commodity on a farm, producers may select the Price Loss Coverage (PLC) program to receive a payment on 85% of base acres when the annual national average farm price is below the reference price set in statute. This option could be attractive if farmers expect farm prices to drop below statutory minimums.

Payments are proportional to a farm's base acres, historical farm yield, and the difference between the reference price and the annual farm price. Hence payments are generally "decoupled" from planted acreage and actual yield but not price. PLC payments operate the same as CCPs under the 2008 farm bill, which have been reported to the WTO by the United States as "amber box" subsidies, and thus limited in size together with other amber box subsidies.

Commodity groups successfully argued for an increase in reference prices relative to the payment trigger levels in the 2008 farm bill (i.e., target price minus direct payment rate). For example, the payment trigger level has been raised by 51% for wheat, 57% for corn, 51% for soybeans, 72%

for rice (98% for temperate Japonica rice), and 17% for peanuts. Reference prices and a comparison with 2008 farm bill parameters for each covered commodity are shown in **Table 1**.

The PLC payment formula is 85% *times* the number of base acres *times* historical payment yield *times* the difference between the reference price and the annual farm price (or loan rate if higher). See **Figure 1** for a graphical interpretation of the formula and **Figure 2** for a hypothetical example for rice. The historical payment yield is equal to 90% of the 2008-2012 average yield per planted acre for the farm. As an alternative, the producer can keep the program yield used for calculating CCPs in the 2008 farm bill (generally based on 1998-2001 yields).



Figure 1. Price Loss Coverage (PLC)


(makes payment when national average farm price drops below the reference price)

Agriculture Risk Coverage (ARC)

Producers more concerned about declines in crop revenue (i.e., yield times price) than just price can select the county Agriculture Risk Coverage (ARC) program as an alternative to PLC for each covered commodity. Payments are made on 85% of base acres when annual crop revenue is less than 86% of its historical level.

If farmers prefer individual farm level protection, they must enroll *all* covered crops on the farm in the ARC-individual coverage option instead of selecting between PLC and county ARC for each crop.

County ARC

For producers choosing between ARC and PLC on each covered commodity on a farm, the county ARC program has a county revenue guarantee, and only a crop revenue loss at the county level triggers a payment. For ARC county coverage, payments are made on 85% of base acres when actual county crop revenue drops below the county revenue guarantee, which is 86% of historical or "benchmark" revenue. The benchmark revenue per acre is equal to the average historical county yield for the most recent 5 crop years (excluding the years with the highest and lowest yields, or "Olympic average") times the national average market price received by producers during the 12-month marketing year for the most recent 5 crop years (excluding the years with the highest and lowest prices). With the guarantee set at 86%, the producer absorbs the first 14% of the shortfall, and the government absorbs the next 10% of revenue shortfall. (The per-acre payment rate is capped at 10% of benchmark revenue.) Remaining losses are backstopped by crop insurance if purchased at sufficient coverage levels by the producer and by the marketing assistance loan program.

The county ARC payment formula is 85% *times* the number of base acres *times* the difference between the county revenue guarantee and the actual crop revenue. See **Figure 3** for a graphical interpretation of the formula and **Figure 4** for a hypothetical example for corn.

Individual ARC


Farm level protection is provided if producers enroll *all* covered crops on the farm in the ARC-individual coverage option, which uses individual farm yields for each covered crop (which are more variable than county averages) and aggregates all crop revenue into a single, whole-farm guarantee. Individual coverage was not available for ACRE in the 2008 farm bill; farm-level coverage was provided instead by the Supplemental Revenue Assistance (SURE) disaster program (not reauthorized under the 2014 farm bill).

The individual ARC payment formula is 65% *times* the number of total base acres for the farm *times* the difference between the revenue guarantee and the actual crop revenue. The calculation for the guarantee and actual revenue are based on the aggregation of all covered crops on the farm using individual farm yields instead of county yields.¹²

Figure 3. Agriculture Risk Coverage (ARC)-County Coverage


(payment when actual county-wide revenue drops below 86% of historical revenue ["shallow loss"])

Marketing Assistance Loan Program

The Marketing Assistance Loan (MAL) program provides additional financial benefits to farmers in the form of a guaranteed floor price for qualifying field crops, in addition to providing short-term financing. The process begins with a government loan to participating farmers of designated crops (covered commodities, plus upland cotton, extra long staple cotton, wool, mohair, and honey). The loan is made at a specified "per-unit" loan rate using the crop as collateral. This loan rate, in effect, establishes a price guarantee. Prior to loan maturity, if the local market price (called the "posted price") is at or above the loan rate, the farmer repays the loan principal and interest. In contrast, when the posted price is below the loan rate, the farmer may repay the loan at that price (called the "loan repayment rate") and pocket the difference as a "marketing loan gain." Or, rather than taking the loan when the posted price is below the loan rate, farmers may request a "loan deficiency payment," with the payment rate equal to the difference between the loan rate and the loan repayment rate.

Program benefits are available on the entire crop produced, which means a farmer receives no benefits in the event of a crop loss. This is in contrast to the other two programs (PLC and ARC) that make payments on historical acres and yields and therefore are not dependent on current production.

In the 2014 farm bill, for 2014-2018 crop years, loan rates remain the same as prior law except for upland cotton (see **Table 1** for loan rates). The loan rate for upland cotton is changed from \$0.52 per lb. to the simple average of the adjusted prevailing world price for the two immediately preceding marketing years, but not less than \$0.45 per pound or more than \$0.52 per pound.

Given recent relatively high price levels, the MAL program has paid only limited benefits in recent years for most crops. As a result, some farmers have criticized loan rates as being too low relative to prevailing market prices. MAL program benefits, combined with payments under PLC and ARC, are subject to a payment limit of \$125,000 per person for all covered commodities (except peanuts, which has a separate limit of \$125,000). Benefits derived from loan forfeitures are exempt from the limit. The 2008 farm bill did not have a payment limit for MAL.

Cotton Not Eligible for Either PLC or ARC

Beginning with the 2014 farm bill, cotton is no longer a covered commodity and not eligible for PLC/ARC payments. Instead it is eligible for a new crop insurance policy called Stacked Income Protection or STAX. Cotton remains eligible for MAL but the loan rate was altered slightly as specified above.

The policy revision was sought by U.S. cotton producers in an attempt to resolve a long-running trade dispute with Brazil that requires changing the U.S. cotton support program so it does not

distort international markets.¹⁵ As part of the transition, farm payments are made for upland cotton for the 2014 crop year, and for 2015 if STAX is not available. Payment acres in 2014 equal 60% of 2013 cotton base acres and 36.5% of 2013 cotton base acres in 2015.

Separately, the 2014 farm bill specifies that upon resolution of the trade dispute, funds paid by the U.S. government to Brazil (as part of an agreement made in 2010) may be used for research conducted collaboratively between Brazil and USDA research agencies or with a college, university, or research foundation located in the United States. Among several provisions, the agreement required annual payments of \$147.3 million from the United States (via the Commodity Credit Corporation, CCC) to Brazil in order to provide technical assistance and capacity-building for Brazil's cotton sector, but it explicitly excluded funding research.

Planting Fruits and Vegetables on Base Acres

Any crop may be planted without effect on base acres. However, payment acres on a farm are reduced in any crop year in which fruits, vegetables (other than mung beans and pulse crops), or wild rice have been planted on more than 15% of base acres (or 35% in the case of the individual coverage option for ARC). The reduction to payment acres is one-for-one for every acre in excess of these percentages. This allows a limited amount of fruits and vegetables without penalty. Unlike in the past when the reduction in payment acres began at the first acre of fruits and vegetables on base acres, the 2014 farm bill allows 15% (or 35% for individual ARC) of base acres to be planted to fruits and vegetables before the reduction in payment acres begins.

Payment Limits

The enacted 2014 farm bill sets a \$125,000 per person cap on the total of PLC, ARC, marketing loan gains and loan deficiency payments. The limit applies to the total from all covered commodities except peanuts, with a separate \$125,000 limit for peanuts (for both, limits are doubled with a spouse). This is in contrast to the 2008 farm bill, which had applied limits for each program, specifically \$40,000 per person for direct payments, \$65,000 for counter-cyclical and ACRE payments, and no limit on marketing loan gain or LDPs.

"Actively Engaged"

To be eligible for payments, persons must be "actively engaged" in farming. Actively engaged, in general, is defined as making a significant contribution of (i) capital, equipment or land, and (ii) personal labor or active personal management. Also, profits are to be commensurate with the level of contributions, and contributions must be at risk. Legal entities can be actively engaged if members collectively contribute personal labor or active personal management. Special classes allow landowners to be considered actively engaged if they receive income based on the farm's operating results, without providing labor or management. Under the 2008 farm bill, spouses were considered actively engaged if the other spouse meets the qualification, allowing payment limits to be doubled.

The 2014 farm bill instructs USDA to write regulations that define "significant contribution of active personal management" to more clearly and objectively implement existing law. The regulation is to apply beginning with the 2015 crop year, and entities made solely of family members are exempt. This final provision differs from earlier Senate-passed and House-passed versions of the 2014 farm bill, which would have deleted "active personal management" and effectively required personal labor in the farming operation. The final 2014 farm bill provision instructs USDA to consider different limits for varying types of farming operations, based on considerations of size, nature, and management requirements of different farming types, changes in the nature of active personal management due to advancements in farming practices, and the impact of this regulation on the long-term viability of farming operations.

Adjusted Gross Income (AGI) Limit

To qualify for any commodity program benefits, recipients must pass an eligibility requirement based on adjusted gross income (AGI) used for federal taxes. The enacted 2014 farm bill establishes the AGI limit as a single, total AGI limit of \$900,000 (using a three-year average). In contrast, the 2008 farm bill had two separate limits—farm and non-farm. The non-farm AGI limit was \$500,000 to qualify for and receive any farm commodity program benefits, Milk Income Loss Contract (MILC) program, noninsured crop assistance (NAP), or disaster payments. The second limit was \$750,000 on farm AGI to receive direct payments.

Some individuals who previously qualified for farm program payments might no longer qualify due to the lower overall limit (\$900,000 compared with the combined 2008 farm bill limits of \$500,000 and \$750,000). However, others might regain eligibility if nonfarm income is high (i.e., between the previous non-farm limit of \$500,000 and the new total limit of \$900,000) and farm income is low enough to prevent total AGI from exceeding the 2014 farm bill AGI limit of \$900,000.

Interaction with Federal Crop Insurance

Federal crop insurance intersects with farm programs when producers choose between the Agriculture Risk Coverage (ARC) and the Price Loss Coverage (PLC) programs. The ARC program is a "shallow loss" program that makes a payment when actual crop revenue is more than 14% below the ARC guarantee. For producers who select the PLC, "shallow loss" coverage is available by purchasing a new crop insurance product called Supplemental Coverage Option (SCO) authorized in Title XI of the 2014 farm bill. SCO is designed to cover part of the deductible on a producer's underlying crop insurance policy. SCO is not available for those enrolled in ARC.

Estimated Cost of the Commodity Title




Figure 5. Outlays for Farm Commodity Program and Disaster Assistance

Because spending on the farm commodity programs involves market-driven counter-cyclical payments, annual outlays can be highly variable. **Figure 5** shows that, from 1990 to 2013, commodity program outlays (including dairy programs and disaster payments) were about \$5 billion both at the beginning and the end of this period. The high was \$27 billion in 2000 when Congress authorized a large sum of "market loss assistance" payments in response to significant price declines in the crop sector. The average over the entire period was \$10.1 billion per year.

In January 2014, the Congressional Budget Office (CBO) estimated that for the 2014-2023 period, farm commodity (and disaster program) spending will be \$4.4 billion annually, well below the historical averages due to the elimination of direct payments and relatively strong market prices projected by CBO. Given the counter-cyclical design of farm programs, if commodity prices are higher than projected, government outlays will be below projected levels (and vice versa).

Compared to the baseline of continuing the provisions of the 2008 farm bill, the CBO cost estimate (score) of the new provisions in Title I of the farm bill represents five-year savings of \$6.3 billion and 10-year savings of \$14.3 billion (both relative to baseline projections made in May 2013). If the scores of these changes are added to the 2013 baseline of budget outlays used to write the farm bill, then CBO's expected cost of Title I is \$23.6 billion for FY2014-2018 and \$44.5 billion over 10 years (**Table 2**). This includes the program crop commodities, dairy, disaster programs, and sugar (no program change).

The 5- and 10-year savings that are scored for all of Title I are the net result of various provisions that either score savings or cost more than prior law. The savings is the result of the elimination of direct, counter-cyclical, and ACRE payments. Also, payments for PLC/ARC are made with a one-year lag, which shifts about \$3 billion of payments into a later fiscal year. This achieves savings in the 10-year budget window but does not reduce the total amount eventually paid to farmers. Some of the Title I savings are offset with costs of the new PLC and ARC programs, transition payments to producers of upland cotton (not eligible for PLC/ARC), reauthorized disaster programs, and a revised dairy program.

Implementation

The 2014 farm bill provides \$100 million to carry out Title I. A portion of the total (\$3 million) is marked for educating producers on new commodity, dairy, and disaster programs; and \$3 million for web-based program decision tools to help producers make their farm program choices (base reallocations, yield updates, PLC vs. ARC). Congress emphasized the importance of the Acreage Crop Reporting and Streamlining Initiative by making available an additional \$10 million if USDA makes sufficient progress by September 2014 and another \$10 million if it is fully implemented by September 30, 2015. USDA and university extension service offices have begun publishing information on the 2014 farm bill programs. ¹⁶

USDA announced in late February 2014 that the department intends to issue the regulations for PLC and ARC in the fall of 2014.¹⁷ Once the regulations are in place, USDA indicates that producers can then update producer information and make program choices by late 2014 and early 2015. By then, producers will likely have a general indication about 2014 crop prices, and which program (PLC or ARC) will result in a higher farm payment. The decision is irrevocable for the life of the 2014 farm bill, so producers will need to consider not just 2014 prices, but also expected prices through 2018. Also, wheat farmers can enroll in the Supplemental Coverage Option policy (authorized in the 2014 farm bill) but can later opt out if they select ARC.

United States premium factor: the percentage by which the difference in the United States loan schedule premiums for Strict Middling (SM) | 1 //8-inch upland cotton and for Middling (M) | 1 3/32-inch upland cotton exceeds the difference in the applicable premiums for comparable international qualities. **[7 U.S.C. 8702(18)]**

United States: same as prior law. [Sec. 1111(23)]

United States premium factor: same as prior law. [Sec. 1111(24)]

Base, Payment Yields, and Payment Acres

Base acres: Unlike 2002 farm bill, no provision in 2008 farm bill for reallocating base acres among crops to reflect recent plantings.

Accommodations for double cropping and CRP acres. Base cannot exceed total cropland. [7 U.S.C. 7911]

Payment yields: Established direct payment yields for designated oilseeds, camelina, or pulse crops using 1998-2001 farm yields, adjusted back to the national average from 1981-85. For counter-cyclical payments, yield could be updated to reflect yields during 1998-2001 using specific formulas. [7 U.S.C. 7912]

No comparable provision.

Base acre retention or one-time reallocation: Farm owners have a one-time opportunity to either: (1) retain base acres (including any generic base acres), or (2) reallocate base acres (other than any generic base acres) among covered crops to reflect recent historical planting shares equal to the 4-year average (2009-2012) planted area for each covered crop (including prevented plant acreage). Additional provisions: all four years are included in the average (even if zero); with multiple plantings per years, only one crop may be used in the calculation; reallocation of base acres among covered commodities may not result in an increase in total base acres (including generic base). [Sec. 1112(a)]

Similar to prior law, including provision to increase/decrease base when land leaves/enters conservation programs. [Sec. III2(b)] However, base is reduced if the sum of the base acres for the farm (including any new oilseed acreage and generic base acres) plus any acreage in CRP or the Wetlands Reserve Program (or other federal conservation program that makes payments in exchange for not producing a crop) exceeds the actual cropland acreage on the farm. Payment yields: For Price Loss Coverage payments under Section 1116, the Secretary shall establish a yield for each farm for any designated oilseed for which a payment yield was not established under Section 1102 of the 2008 farm bill. If the yield per planted acre for a crop of a designated oilseed for a farm for any of the 1998 through 2001 crop years was less than 75% of the county yield for that designated oilseed, the Secretary shall assign a yield for that crop year equal to 75% of the county yield. [Sec. 1113(a-c)]

Updating payment yields for Price Loss Coverage (PLC): The owner of a farm has a I-time opportunity to update, on a covered commodity-by-covered-commodity basis, the payment yield used in calculating PLC payments for each covered commodity. The PLC payment yield is equal to 90% of the average of the yield per planted acre for the crop of the

Payment acres: 85% of the base acres of a covered commodity on a farm on which direct payments and counter-cyclical payments are made. Exception: 83.3% of base acres for direct payments only for crop years 2009-2011. [7 U.S.C. 7901(10)]

Farms with limited base acres: A producer on a farm may not receive direct payments, counter-cyclical payments, or average crop revenue election payments (see below) if the sum of the base acres of the farm is 10 acres or less (provision was suspended for the 2008 crop year only). [7 U.S.C. 8711(d)]

Planting flexibility: Any crop may be planted on base acres to receive program benefits, except fruits, vegetables (other than mung beans and pulse crops), and wild rice. Exceptions provide for farms and producers with a history of double-cropping or history of growing fruits and vegetables; in this case, direct and counter-cyclical payments are reduced acre-for-acre for the year. [7 U.S.C. 8717, 7 U.S.C. 8756] A pilot program beginning in 2009 in seven Midwestern states allowed planting of fruits and vegetables for processing on base acres. Base acres were temporarily reduced for the year, but restored for the next crop year and "considered planted" for any future base calculations. [7 U.S.C. 8717(d)]

covered commodity for the 2008 through 2012 crop years, excluding any crop year in which the acreage planted to the crop of the covered commodity was zero. If the yield for any of the 2008 through 2012 crop years was less than 75% of the average county yield during that period, a "plug" yield for that crop year is equal to 75% of the county average for 2008 through 2012. [Sec. 1113(d)]

Payment acres: For Price Loss Coverage (PLC) and the Agriculture Risk Coverage (ARC) when county coverage has been selected, the number of payment acres for each covered commodity on a farm is equal to 85% of the base acres for the covered commodity. In the case of ARC when individual coverage has been selected, the payment acreage is equal to 65% of the base acres for all of the covered commodities on the farm. [Sec. 1114(a)] Payment acres may not include any crop subsequently planted during the same crop year on the same land for which the first crop is eligible for PLC payments or ARC payments, unless the crop was approved for double cropping in the county, as determined by the Secretary. [Sec. 1114(c)]

Generic base is eligible for payments if a covered crop is planted on the farm. Specifically, for each crop year, generic base acres are attributed (i.e. temporarily designated as) base acres to a particular covered commodity base in proportion to that crop's share of total plantings of all covered commodities in that year. The amount of generic base attributed for a particular year cannot exceed the acreage planted to covered crops in that year. In other words, if the total number of acres planted to all covered commodities on the farm does not exceed the generic base acres on the farm, only the amount of acreage actually planted to a covered commodity is attributed to that covered commodity for payment purposes. [Sec. 1114(b)]

Minimal payment acres: A producer on a farm may not receive Price Loss Coverage payments or Agriculture Risk Coverage payments (see below) if the sum of the base acres on the farm is 10 acres or less, except for socially disadvantaged farmers/ranchers or limited resource farmers/ranchers, [Sec. 1114(d)]

Effect of planting fruits and vegetables: Any crop may be planted without effect on base acres. However, payment acres on a farm are reduced in any crop year in which fruits, vegetables (other than mung beans and pulse crops), or wild rice have been planted on base acres. The reduction to payment acres is one-for-one for each acre planted to these crops in excess of 15% of base acres for either the Price Loss Coverage or county coverage under the Agriculture Risk Coverage (ARC) program, and in excess of 35% of base acres for ARC individual coverage. [Sec. 1114(e)]

Prior Law: 2008 Farm Bill (P.L. 110-246)

Producer election: Producers may choose between the Counter-cyclical payments (CCPs) and Average Crop Revenue Election (ACRE) payments. If CCP was selected, direct payments were reduced 20% and marketing loan rates are reduced by 30%. Producers can enter ACRE any year of the 2009-2012 crop years, but cannot return to the traditional counter-cyclical program. **[7 U.S.C. 8715(a)(1)]** If all of the producers on a farm fail to make an election or make different elections, all of the producers on the farm are deemed to have made the election to receive counter-cyclical payments. **[7 U.S.C. 8715(a)(5)]** After the 2008 farm bill was extended by I year by the American Taxpayer Relief Act of 2012, producers were offered the same choice for the 2013 crop year.

Current Law: 2014 Farm Bill (P.L. 113-79)

Producer election: For the 2014 through 2018 crop years, all of the producers on a farm shall make a one-time, irrevocable election to obtain either Price Loss Coverage on a covered commodity-by-covered-commodity basis; or Agriculture Risk Coverage. [Sec. 1115(a)] For ARC, producers must unanimously select whether to receive ARC payments based on: (1) county coverage applicable on a covered-commodity-by-covered-commodity basis: or (2) individual coverage applicable to all of the covered commodities on the farm. [Sec. 1115(b)] If all the producers on a farm fail to make a unanimous election for the 2014 crop year, no program payments are made to the farm for the 2014 crop year and the producers on the farm shall be deemed to have elected PLC for all covered commodities on the farm for the 2015 through 2018 crop years. [Sec. 1115(c)] If all the producers on a farm select ARC county coverage for a covered commodity, the Secretary cannot make PLC payments to the producers on the farm with respect to that covered commodity. [Sec. 1115(d)] If all the producers on a farm select individual coverage, payment calculations include the producer's share of all farms in the same state in which the producer has an interest and for which individual coverage has been selected. [Sec. 1115(e)] Producers on a farm cannot reconstitute the farm to void or change a program election. [Sec. 1115(f)]

Price-Based Payments

Counter-cyclical payments (CCPs) are available for covered commodities for 2008-2013 crop years when the farm price is below the effective price (target price in statute minus the direct payment rate). [7 U.S.C. 8714]

Payment rate is the difference between target price in statute and the national 12-month average farm price (or loan rate, if higher), minus the direct payment rate. Counter-cyclical payments for peanuts authorized separately. [7 U.S.C. 8754(a)(1)-(3)]

Payment amount = Payment rate times 85% of base acres times counter-cyclical program yield for the farm (generally based on 1998-2001 data). [7 U.S.C. 7912]

Repeals counter-cyclical payments. [Sec. 1102]

Establishes similar program called **Price Loss Coverage (PLC)** for crop years 2014-18. PLC payments are made on a farm on a covered commodity-by-covered-commodity basis if the effective price (the higher of the national average 12-month market price or the loan rate) is less than the reference price.

Payment rate is the difference between the reference price in statute and the national 12-month average market price (or loan rate, if higher). **[Sec. 1116]**

Payment amount = Payment rate times 85% of base acres for each covered commodity (including attributed generic base) times existing counter-cyclical program yield (or updated yields equal to 90% of 2008-2012 average yield per planted acre). **[Sec. 1116(d)]** (See Sec. 1113 for more on payment yields.)

Payments shall be made beginning October I, or as soon as practicable thereafter, after the end of the applicable marketing year for the covered commodity. [Sec. 1116(e)]

Revenue-Based Payments

For covered commodities and peanuts, Average Crop Revenue Election (ACRE) payments are available to producers as an alternative to CCPs. [7 U.S.C. 8715]

Revenue payment based on a two-part trigger: (1) if the actual state revenue is less than a guaranteed state level for the commodity, and (2) if actual farm revenue is less than a farm ACRE benchmark for the commodity. [7 U.S.C. 8715(b)(2)]

Actual state revenue per acre = actual state yield, times the national average market price. Actual state yield is the actual quantity produced in the state during the crop year, divided by planted acres. [7 U.S.C. 8715(c)] National average market price is the greater of the national average price received during the 12-month marketing year, or the marketing loan rate after being reduced by 30%. [7 U.S.C. 8715(a)(1)]

Actual farm revenue per acre = actual farm yield, times the greater of the national average price received during the 12-month marketing year or the marketing loan rate after being reduced by 30%. [7 U.S.C. 8715(e)]

ACRE program guarantee per acre = 90% times the benchmark state yield, times the ACRE program guarantee price. [7 U.S.C. 8715(d)]

The benchmark state yield is a 5-year Olympic average state yield. [7 U.S.C. 8715(d)(2)(A)] The ACRE program guarantee price is a 2-year average of the national average market price. [7 U.S.C. 8715(d)(3)]The ACRE program guarantee cannot change more than 10% from the previous year. [7 U.S.C. 8715(d)(1)(B)]

Farm ACRE benchmark revenue per acre = the 5-year Olympic average farm yield, times the ACRE program guarantee price; plus the crop insurance premium per acre. [7 U.S.C. 8715(f)]

Repeals Average Crop Revenue Election (ACRE) program. [Sec. 1103]

Establishes similar program called **Agriculture Risk Coverage (ARC)** as an alternative to PLC payments for crop years 2014-18 on a commodity-by-commodity basis for each farm (except when producers select individual (farm) ARC, then PLC is not an option for any commodity). Producers select either county coverage or individual farm coverage. **[Sec. 1117]**

Revenue payment based on single trigger: if the actual crop revenue is less than the agriculture risk coverage guarantee. [Sec. III7(a)]

In the case of county coverage, **actual crop revenue** per acre = the actual average county yield per planted acre for the covered commodity times the higher of (i) the national average market price received by producers during the 12-month marketing year, or (ii) the national average loan rate. [Sec. 1117(b)(1)]

In the case of individual (farm) coverage, actual crop revenue per acre is the producer's share of the aggregated revenue amount for all covered commodities planted on all farms for which individual coverage has been selected. Actual crop revenue is equal to the sum of covered commodity revenue (total production of each covered commodity on such farms, times the higher of (i) the national average market price received by producers during the 12-month marketing year, or (ii) the national average loan rate) divided by the total planted acres of all covered commodities on such farms. [Sec. 1117(b)(2)]

ARC guarantee per acre = 86% times the benchmark revenue. [Sec. 1117(c)(1)]

In the case of <u>county coverage</u>, **benchmark revenue** per acre = the average historical county yield for the most recent 5 crop years (excluding the years with the highest and lowest yields, or "Olympic average") times the national Olympic average market price received by producers during the 12-month marketing year for the most recent 5 crop years. [Sec. 1117(c)(2)]

In the case of <u>individual coverage</u>, **benchmark revenue** is based on the producer's share of all covered commodities planted on all farms for which individual coverage has been selected and in which the producer has an interest. Benchmark revenue is the summation of Olympic 5-year average benchmark revenue for each covered commodity aggregated across all farms with individual coverage, adjusted to reflect current-year planted acreage. Annual revenue for each covered commodity is equal to the farm yield per planted acre for the covered commodity, times the national average market price received by producers during the 12-month marketing year. [Sec. 1117(c)(3)]

If more than 25% of a state's acreage is irrigated and 25% is non-irrigated, separate guarantees shall apply. [7 U.S.C. 8715(d)(4)]

Payment amount = the product of (1) the lesser of (a) the ACRE program guarantee minus actual state revenue or (b) 25% of the ACRE program guarantee, times (2) 83.3% (2009-2011) or 85% (2012 and 2013) of the acreage planted of the covered commodity (not to exceed base acres of the commodity), times (3) the 5- year Olympic average farm yield divided by the 5-year Olympic average state yield. This formula multiplies a state-level payment rate per acre (up to a maximum of 25% of the guarantee level) times a percentage of planted acreage, then prorates the payment based on the farm's yield history compared to the state's yield history. **[7 U.S.C. 8715(g)]**

For producers who participate in ACRE, loan rates under the marketing assistance loan program are reduced 30% and direct payments are reduced by 20%. [7 U.S.C. 8715(a)(1)]

Timing: Beginning October 1 after the end of the marketing year. [7 U.S.C. 8715(b)(3)] No comparable provision.

If the yield per planted acre for the covered commodity or historical county yield per planted acre for the covered commodity for any of the 5 most recent crop years is less than 70% of the transitional yield, the amounts used for any of those years is equal to 70% of the transitional yield. [Sec. 1117(c)(4)]

The reference price is used if the national average farm price for any of the 5 most recent crop years is lower than the reference price. [Sec. 1117(c)(5)]

To the maximum extent practicable, calculate separate ARC guarantees for irrigated and nonirrigated covered commodities. [Sec. 1117(g)(2)]

The **payment rate** for a covered commodity, in the case of county coverage, or a farm, in the case of individual coverage, is equal to the lesser of: (1) the amount that the ARC guarantee for the crop year exceeds the actual crop revenue for the crop year, or (2) 10% of the benchmark revenue for the crop year. [Sec. 1117(d)]

Payment amount = the payment rate times the payment acres.

For county coverage, payment acres = 85% of the base acres for the covered commodity. For individual coverage, payment acreage = 65% of the base acres for all of the covered commodities on the farm. [Sec. 1117(e)]

Timing: Beginning October Tafter the end of the marketing year. [Sec. 1117(f)]

Additional duties of the Secretary: Use all available information and analysis, including data mining, to check for anomalies in the determination of ARC payments; if necessary, assign an average yield for a farm or county on the basis of the yield history representative of the area. [Sec. 1117(g)]

Conservation Compliance/Producer Agreement

Eligibility for direct payments, counter-cyclical payments, or average crop revenue election payments requires producers to comply with conservation, wetland, and planting flexibility requirements; use base acres for agricultural or conserving use, and not for nonagricultural commercial, industrial, or residential use; control noxious weeds and maintain sound agricultural practices. Producers must submit annual acreage reports for all cropland on the farm; for those who receive ACRE payment, annual production reports are also required. [7 U.S.C. 8716(a)(c)] Same provision for peanuts (except production report requirement). [7 U.S.C. 8755(a)(c)] Under Title II (Conservation) of the 2008 farm bill (P.L. 110-246), benefits under the marketing loan program are subject to conservation compliance for highly erodible land [16 U.S.C. 3811(a)(1)(A)] and for Swampbuster [16 U.S.C. 3812(a)(1)].

Similar to prior law, with application to the new Price Loss Coverage (PLC) and Agriculture Risk Coverage (ARC) programs, and marketing loans. [Sec. 1118(a)] Annual production reports are required for producers selecting individual ARC coverage. [Sec. 1118(c)] No penalties can be assessed against a producer for an inaccurate acreage or production report unless the Secretary determines that the producer knowingly and willfully falsified the report. [Sec. 1118(e)]

Separately, in Title II (Conservation), a producer must be in compliance with highly erodible land conservation requirements and wetland requirements in order to receive crop insurance premium subsidies. [Sec. 2609]

Prior Law: 2008 Farm Bill (P.L. 110-246)

Current Law: 2014 Farm Bill (P.L. 113-79)

Sets requirements for transfer of interest in base acres. Protects interests of tenants and sharecroppers and provides for sharing of payments on a farm on an equitable basis. [7 U.S.C. 7915(b)(d)(e)] Same provision for peanuts. [7 U.S.C. 7955(b)(d)(e)]

Transition Payments

No comparable provision.

Transition (direct) payments are made for upland cotton for the 2014 crop year, and for 2015 if STAX insurance product (Title XI) is not available.

Payment equals program yield (divided by the national yield of 597 pounds per acre) times transition assistance rate times payment acres. Transition rate is based on cotton price decline between June 2013 and December 2013. Payment acres in 2014 equal 60% of 2013 cotton base acres and 36.5% in 2015. [Sec. 1119]

Nonrecourse Marketing Loans and Other Recourse Loans

Nonrecourse marketing loans are available for any amount of a loan commodity (see list below) produced in crop years 2008-2013. [7 U.S.C. 8731] Nonrecourse marketing loans for peanuts are authorized separately. [7 U.S.C. 8757]

For peanuts, nonrecourse marketing loans available in crop years 2008-2013. May be obtained through a marketing cooperative or association approved by USDA. Storage to be provided on a non-discriminatory basis and under any additional requirements. Payment of peanut storage costs authorized for 2008-2013 crops. [7 U.S.C. 8757(a)(4)-(7)]

Loan deficiency payments (LDP) are available to producers who agree to forego marketing loans. LDP computed by multiplying the payment rate (the amount that the loan rate exceeds the rate at which a marketing loan may be repaid) for the commodity times the quantity of the commodity produced. Loan deficiency payments available for unshorn pelts or hay and silage, even though they are not eligible for marketing loans. ELS cotton is not eligible.
