Motion for Extension of Time**

On July 24, 2015, Randall Jones filed a motion to extend the time for filing a petition for reconsideration of *Jones*, No. 13-0053, 2015 WL 4538820 (U.S.D.A. June 29, 2015). On July 28, 2015, counsel for Kevin Shea, Acting Administrator, Animal and Plant Health Inspection Service, United States Department of Agriculture [Administrator], by telephone, informed the Office of the Judicial Officer that the Administrator opposes Mr. Jones’ motion for extension of time.

The rules of practice applicable to this proceeding<sup>1</sup> provide that a party to a proceeding may file a petition to reconsider the decision of the Judicial Officer within 10 days after the date of service of the decision upon the party filing the petition.<sup>2</sup>

The Hearing Clerk served Mr. Jones with *Jones*, No. 13-0053, 2015 WL 4538820 (U.S.D.A. June 29, 2015), on July 3, 2015,<sup>3</sup> and Mr. Jones was required to file a petition for reconsideration of *Jones*, No. 13-0053, 2015 WL 4538820 (U.S.D.A. June 29, 2015), no later than July 13, 2015. As Mr. Jones filed his motion to extend the time for filing a petition for reconsideration 11 days after Mr. Jones' petition for reconsideration was required to be filed, Mr. Jones' motion for an extension of time to file a petition for reconsideration of *Jones*, No. 13-0053, 2015 WL 4538820 (U.S.D.A. June 29, 2015), is denied.

For the foregoing reasons, the following Ruling is issued.

### **RULING**

Mr. Jones' July 24, 2015, motion for an extension of time to file a petition for reconsideration of *Jones*, 2015 WL 4538820 (U.S.D.A. June 29, 2015), is denied.
