The National Agricultural Law Center

- Created by Congress in 1987 (original grant executed 4/13/1988)
- We are the nation's leading source for agricultural and food law research and information
 - www.nationalaglawcenter.org
- Objective/neutral, non-partisan research and information regarding laws and regulations affecting agriculture
 - What the law is, rather than what the law should be
- Stakeholder-driven
- The only institution of its kind in the United States

NALC: In The Beginning, April 1988

- "The center will provide timely, neutral international, state and federal legal research and information to practicing attorneys, farm and commodity groups, farmers' aid organizations, state and federal agencies, members of Congress and others who are helping farmers and farmer-related industries deal with the crushing legal challenges facing them today."
- "To establish a national clearing house for systematic collection, indexing, and publication of agricultural law information."
- "To coordinate with the Cooperative Extension Service in providing information to producers in planning programs on agricultural law issues."
- "To provide support to educational programs in agricultural law in the land grant universities and in other institutions of higher education."
- "To coordinate with natural organizations, such as the American Agricultural Law Association, in the dissemination of information on agricultural law matters to members and other groups."


NALC: Specific Types of Outreach

NALC: Website

- Comprehensive collection of ag & food law research and information
- Designed with goal of being usable to non-attorneys and attorneys, nonexperts and experts
- 20% gain year-over-year
- 2022 average = approx. 780 daily visits

- Agricultural Law course, coteaching with John Allen Nichols (ALFA)





Past/Current Examples

- Essentially are "mini-grants"
- The Veterinary Feed Directive Rules and How They Will Affect You (2016)
- Assist minority, small, and limited-resource farmers understand their legal responsibility and rights pertaining to land, business, and heirs
 - Engaging with attorneys as part of project
- Digesting the FSMA Animal Feed Rule
