### Need to Know: The Corporate Transparency Act

It is crucial for business owners across the country to understand the Corporate Transparency Act (CTA), which went into effect on Jan. 1, 2024. The CTA requires millions of small business entities (in agriculture and beyond) to file with the federal government,

making known their beneficial owners. Failure to report may result in criminal penalties. Senior Staff Attorney Rusty Rumley gives background on the CTA in **this Southern Ag Today article**.


