- 1. Then-Acting-Chief Judge Janice K. Bullard assigned to me for hearing and decision this case, 16-0079, on March 18, 2016.
- 2. Counsel for APHIS Mr. Rodriguez is requested to try to contact Respondent Donald C.R. Hinkel using the current business address of ABC Janitors of St Croix Inc.
- 3. ABC Janitors of St Croix Inc. is a carrier registered with the United States Department of Transportation (USDOT) Number 369501, primary contact Donald Hinkel. Current contact information for ABC Janitors of St Croix Inc. may be 4000 La Grande Princess, Suite A, Christiansted, St Croix USVI 00820. Phone Number (340) 773-3780. Fax Number (340) 773-4770.
- 4. The parties are encouraged to explore whether a Consent Decision may be negotiated to resolve all issues in this case.

^{1.} The Complainant is the Administrator, Animal and Plant Health Inspection Service, United States Department of Agriculture ("APHIS" or "Complainant").

- 5. Service upon Respondent Donald C.R. Hinkel (a) of the Complaint filed March 11, 2016; and (b) of the Motion for default decision filed June 15, 2016; may not yet have been accomplished to my satisfaction, as I detail below discussing the Hearing Clerk's mailings.
- 6. The Hearing Clerk sent a copy of the Complaint by certified mail to Donald C.R. Hinkel at a P.O. Box, St. Croix, U.S. Virgin Islands 00824. That P.O. Box was used at one time, but I am not sure when, by carrier ABC Janitors of St Croix Inc., registered with the United States Department of Transportation (USDOT) Number 369501, primary contact Donald Hinkel. On May 3, 2016, the U.S. Postal Service sent the Hearing Clerk's certified mailing back to the Hearing Clerk, and the envelope was marked:

RETURN TO SENDER UNCLAIMED UNABLE TO FORWARD RETURN TO SENDER

- 7. The U.S. Postal Service's addition of "UNABLE TO FORWARD" troubles me. The Hearing Clerk re-sent the copy of the Complaint by regular mail to that same P.O. Box; *see* Memorandum to the File dated May 12, 2016. *See* 7 C.F.R. § 1.147.
- 8. I reserve ruling on whether service of the Complaint occurred on May 12, 2016 under our Rules of Practice. 7 C.F.R. § 1.147. Under the circumstances here, I am not yet persuaded that Donald C.R. Hinkel or carrier ABC Janitors of St Croix Inc. was using that P.O. Box in mid-March 2016 so that the certified mailing was available to Donald C.R. Hinkel in mid-March 2016 to claim or leave unclaimed. I am not yet persuaded that Donald C.R. Hinkel was using that P.O. Box in mid-May 2016, to receive the regular mailing. Investigators with proper authority may obtain information from the U.S. Postal Service regarding person(s) using a P.O. Box. Or, perhaps the information is available from the Department of Transportation. Whether such information will become necessary in this case remains to be seen.
- 9. Regarding the Motion for default decision filed June 15, 2016, the Hearing Clerk sent a copy by certified mail to Donald C.R. Hinkel at 2 different addresses. Both are being returned to the Hearing Clerk. A copy of the USPS Tracking information for each certified mailing is attached. I ask counsel for APHIS Mr. Rodriguez to alert the Hearing Clerk as to the current contact information for Respondent Donald C.R. Hinkel if he can obtain it.
