**Colorado Crisis Services:** This support line operates 24/7 and is available for anyone affected by a mental health, substance use, or emotional crisis. All calls are connected to a mental health professional. Refer to the website for walk-in locations. Contact this line at (844) 493-TALK or visit their website <u>here</u>.

*San Luis Valley Behavioral Health Group:* This service suggests contacting 911 for all lifethreatening situations. If there is no immediate danger, the hotline provides confidential help 24/7. **Solvista Health:** This is a 24-hour crisis service dedicated to helping people stay healthy physically and mentally.
